Anglican Care Advice to Consumers, Families & Friends - COVID-19 Update

Dear Consumers, family and friends,

Following our communication on 16th March 2020, we have decided to implement further strategies to protect our consumers, employees & volunteers from a potential COVID-19 outbreak. As you can imagine, this is a very dynamic situation & recommendations are changing daily. We will endeavour to keep you informed of changes as they occur. We appreciate your continued cooperation & understanding.

Our main priority is protecting the health & wellbeing of consumers within our care. Anglican Care is working closely with local authorities & any strategies implemented are based on recommendations from the Department of Health & the Hunter New England Local Health District. From the 19th March 2020 we will be applying further measures to those outline on 16th March to protect our consumers from a potential COVID-19 outbreak. These measures include:

- 1. Restricting visiting times to between 930am & 330pm daily
- 2. Only two visitor per consumer at a time for 30mins
- 3. No visitors under the age of 16yrs
- 4. All visitors should go directly to the consumers room. Visitors should not be in communal areas.

This is a very difficult & unprecedented time for the aged care industry. We do not take decisions to restrict visitation lightly, however we believe these measures are necessary to protect our vulnerable consumers. Our employees will keep you informed by phone of any changes in your relative or friend.

When visiting our homes we ask that you assist our employees with the screening process & please ensure that hand hygiene is performed on entry to the facility. We have a responsibility to do our very best to prevent the spread of COVID-19 within out homes. I will remind you again, please *do not enter our facilities if you:*

- 1. Have recently returned from international travel
- 2. If you have flu like symptoms and/or have a temperature greater then 38°
- 3. If you have been in contact with a confirmed or suspected case of COVID 19

We are doing all we can to plan to protect consumers receiving a home care package, attending one of our day therapy centres and residents living in our retirement villages or residential care homes, and anticipate your support with this public health issue.
